'Panda games 2016' Terms and Conditions

§ 1 General

1. By entering into the contest being advertised by foodpanda, you (the "Participant") agree to the terms and conditions outlined below. It is important to read and understand these terms and conditions before proceeding further with any participation.

§ 2 Eligibility & Participation

- 1. This contest is being held by Rocket Food Limited ("foodpanda").
- 2. This contest is open to all residents of Hong Kong.
- 3. The minimum age for participants is 18 years of age.
- 4. foodpanda employees, and their direct relatives (spouse and children) may not participate.
- 5. The contest shall run from 5th August 2016 until 21st August 2016 (the "**Period**").
- 6. Participants can take the Quiz multiple times throughout the Period but the participation shall be limited to one time per daily Quiz.
- 7. A Participant shall only be considered eligible if he/she fulfills the criteria mentioned above and performs the actions mentioned in clause 3.3 below.

§ 3 Procedure

- 1. Throughout the Period, foodpanda shall host a quiz on its page (https://www.foodpanda.hk/contents/thepandagames) with sports related questions (the "Quiz").
- 2. The Quiz shall state ten guestions with three (3) multiple choice answers.
- 3. In order to participate, the Participants shall perform the following actions:
 - a. Answer the ten (10) questions;
 - b. Leave their email address at the end of the Quiz.
- 4. All Participants that complete the Quiz and leave a valid email address shall participate in a raffle for the Prizes (as defined below).
- 5. foodpanda shall compile all the Participants who completed the Quiz and randomly select the winners, and their prizes as outlined below.
- 6. foodpanda decisions on the winners, and prizes, will be final.
- 7. Participants agree to be contacted via e-mail or Facebook messaging in accordance with the provisions of clause 7 below.

§ 4 Prizes

- 1. The Prizes shall be:
 - a. Seven Hundred Fifty (750) foodpanda discount vouchers with a minimum order of \$150 (the "**Discount Voucher**") split into fifty (50) foodpanda Discount Vouchers per day during the Period.
 - b. Two (2) KFit Passes for a fixed period of one (1) month which is equivalent to ten (10) fitness classes (the "**KFit Pass**"). The KFit Pass shall

- be redeemed within 1 month (i.e.: by 22nd September, 2016) and shall be auto-renewed at the cost of the winner unless cancelled in advance; and
- c. Three (3) Fave Credit vouchers of a value of one hundred fifty Hong Kong Dollars (150\$) (the "**Fave Credit Voucher**") which shall be redeemable from a variety of outlets by downloading the Fave App. The winners of the Fave Credit Vouchers shall be provided with instructions on how to redeem them.

§ 5 Winners

- 1. The winners of the Prizes shall be selected in the following manner:
 - a. The Discount Vouchers shall be awarded to 50 daily Participants in the Quiz chosen by foodpanda. Each Participant may only be awarded one Discount Voucher during the Period regardless of the number of times they compete.
 - b. The KFit Pass and the Fave Credit Voucher winners shall be randomly selected from all the Participants of the Quiz, on the 22nd of August, 2016 by foodpanda.
- 2. By taking part in the contest, the Participants understand and agree that the above Prizes cannot be exchanged for other items or for cash and foodpanda's decision on the winners and allocated prize is final.
- 3. If foodpanda does not receive a claim to the offered prize by the relevant winners, the Prize will expire after 28 days from notification by foodpanda, who shall have the right to allocate the prize to another Participant.

§ 6 Disqualification

- 1. Any Participant who tries using technology or other means to distort the result of the contest will be immediately disqualified.
- 2. In the event of a disqualification, the next-ranked candidate will receive the prize and so on.

§ 7 Protection of data privacy

- 1. All information provided by the Participant, howsoever provided, shall be processed by foodpanda in accordance with the provisions of the relevant data protection legislation. By providing the information requested the Participant is hereby consenting to being approached by foodpanda for marketing purposes related to foodpanda, and to having such information controlled and processed by foodpanda and shared with third parties, including all foodpanda affiliated entities, on a need to know basis linked to the contest. Should the Participants wish to stop their information from being processed by foodpanda or any third party, they may do so by informing foodpanda in writing, at no cost.
- 2. Termination of information processing before the draw date will result in immediate withdrawal from the contest.

- 3. By entering this contest, participants agree to the above described storage and use of their personal, and submitted, data.
- 4. By entering this contest, the Participants irrevocably agree to the use of their name and image by foodpanda in the event of them winning any of the Prizes. Provided such use is limited to naming the Participant as a winner.
- 5. foodpanda will not pass collected personal data onto third parties except in accordance with the above terms and in accordance with its Privacy Policy.

§ 8 Miscellaneous

- 1. foodpanda reserves the right to temporarily or permanently discontinue the contest without prior notice, for any reason, regardless of whether winners have been announced.
- 2. In this case (before regular operation of the contest) nobody will receive a prize or any reward.
- 3. If a provision of these terms and conditions is or becomes invalid, the validity of the rest of these terms and conditions shall not be affected thereby.
- 4. These Conditions constitute the entire agreement between any Participant and foodpanda in relation to the contest.
